THE VERNON COUNTY COMMISSION MET, PURSUANT TO ADJOURNMENT, ON WEDNESDAY, AUGUST 28, 2013 AT 9:00 A.M.

PRESENT: BONNIE M. MCCORD, PRESIDING COMMISSIONER; NEAL F. GERSTER, NORTHERN COMMISSIONER; AND EVERETT L. WOLFE, SOUTHERN COMMISSIONER.

OSAGE TOWNSHIP

Commission met with Richard Grishow, Department of Conservation; Osage Township Board Members, Dick Webb and Scotty Pritchett, at the site on 1500 Road South of I-49 TT Junction. Commission will replace culverts with bridge and relocate existing concrete culverts. The Conservation Department will contribute rock purchase. Commissioner Gerster will contact Engineer, Jason Eckhardt, for BEAP study/soft match. Commissioner Gerster found later in the day this bridge does not qualify for BEAP Study.

BLUE MOUND TOWNSHIP

Bobby Scotten reported wash out culverts in Blue Mound Township, Section 21, Ezekiel Road. Commissioner Gerster will contact Blue Mound Township Trustee, Dean Gayman. After contacting Mr. Gayman he chose to upgrade to 36 inch culvert.
