THE VERNON COUNTY COMMISSION MET, PURSUANT TO ADJOURNMENT, WEDNESDAY, FEBRUARY 18, 2015 AT 9:00 A.M.

PRESENT: JOE HARDIN, PRESIDING COMMISSIONER; AND NEAL F. GERSTER, NORTHERN COMMISSIONER.

CENTER TOWNSHIP

Wendell Lee called on Commission to view a map of Center Township, Section 18. Mr. Lee questioned easement to road through this section. Commission informed Mr. Lee of the same question last week with Shannon Mays, and it was Commission's opinion that an old road opened in 1915 plotted through that section had never been closed by petition.

LEPC

Commission attended the LEPC meeting.

PUBLIC ADMINISTRATOR

Vernon County Public Administrator, Tammy Bond, called on the Commission to discuss her budget and when her new employees could begin. The budget shows July 1st. She inquired about June 1st. The other employees in her budget will work fewer hours so total payroll would stay within the budget allowed but benefits may be a little higher. Commissioners agreed and gave her permission to start the new full time June 1st if needed.

BRIDGE DEPARTMENT

Vernon County Bridge Foreman, Lynn Seaver, called on Commission to discuss culvert in Harrison Township. It was the same one discussed last week which was felt to be a township culvert, however after reexamining it he determined it was a County culvert and will replace it.

SHERIFF

Chief Deputy, Shayne Simmons, called on Commission to discuss the Sprocket Contract. Deputy Simmons advised Sprocket does not have a contract but wanted to have a non-disclosure agreement, stating they will only use the data for Vernon County emergency personnel.

BRO-B108(42) BRIDGE PROJECT

Commission asked Mr. Mannino to obtain legal descriptions on what we are asking landowners to give, and legal descriptions of what they will be getting as far as the land they will be getting back in return.

Mr. Mannino advised he will obtain the legals and get back with Commission next week. He will need the names of the property owners as he will be drafting the right-of-way acquisition letters to the landowners.
