Motion was made by Commissioner Gerster that the County's records related to GIS systems and records as <u>such exist</u> or <u>hereafter are created</u>, <u>revised</u>, <u>amended or replaced</u> continue to be closed pursuit to the authorizing statutes under Section 610.021(14) RSMo and specifically with respect to Section 67.1850 RSMo that prohibits a person from gaining a specific benefit for such person, not permitted to the general public as related to GIS records and systems.
