THE VERNON COUNTY COMMISSION MET, PURSUANT TO ADJOURNMENT, TUESDAY, AUGUST 11, 2015 AT 9:00 A.M.

Kevin and Sue Bond called on the Commission with concerns about this bridge located near their residence. They had concerns of the ditch on the East side not draining; causing them to not have a permanent telephone line. Commission told the Bond's they would call the Bridge Engineer, as well as our County Bridge Department in attempt to get the ditch fixed. Later in the afternoon Mr. Bond called and left a message for Commission wanting to know the reason the back slope in his yard was not cut. Kevin had previously been in the Clerk's Office and picked up bridge papers that Commissioner Hardin left for him on August 6, 2015. He had also telephoned the Commission Office twice on August 6th. He asked for a copy of the contract and a complete copy of the bridge building. He states he needs it all. He asked when Commissioner Hardin would be back and he was told Tuesday. He states he is tired of "Smoke being blown up my ass!" and he wants to "get this out in the open." He states he is somewhat satisfied with the papers Commissioner Hardin left for him.
