THE VERNON COUNTY COMMISSION MET, PURSUANT TO ADJOURNMENT, TUESDAY, OCTOBER 13, 2015 AT 9:00 A.M.

INSURANCE

Insurance Committee called on the Commission to give their presentation and recommendation on the insurance carrier, as well as the agent; who have submitted bids for the Vernon County Healthcare for 2016. Committee consisted of Angela Kehrman, Tammy Bond, Erik Sommer, Shelly Baldwin, Cherie Roberts and Phil Couch. After the presentation and conversation, the Committee recommended using Blue Cross Blue Shield, being underwritten by Insurance Resource Consultants (IRC).
