THE VERNON COUNTY COMMISSION MET, PURSUANT TO ADJOURNMENT, WEDNESDAY, MARCH 22, 2017 AT 9:00 A.M.

PRESENT: JOE HARDIN, PRESIDING COMMISSIONER ; EVERETT L. WOLFE, SOUTHERN COMMISSIONER; AND CINDY THOMPSON, NORTHERN COMMISSIONER.

OLIVIA PERRY

Olivia Perry called on the Commission with questions in regards to opening an Adult Retail Store. Mrs. Perry was asking about zoning regulations in the county; as she is trying to decide whether to open her business in the city of Nevada or in the county of Vernon. Told Mrs. Perry that the county has no zoning or permitting, but that she should talk to the City of Nevada about their regulations as well as check any state regulations. She will keep the Commission informed on the progress and her decision of where to open her business.

PRESCRIPTION DRUG MONITORING PROGRAM

Motion was made by Commissioner Thompson to adopt and accept an 'Order Approving an Ordinance of the County Commission of Vernon County, Missouri Establishing a Prescription Drug Monitoring Program and Approving an Intergovernmental Cooperative Agreement with City of Nevada and Authorizing Execution of the Same.' Motion was seconded by Commissioner Wolfe. Roll call vote taken: Wolfe (yes), Hardin (yes), Thompson (yes).

Commission held an ordinance joint signing with the City of Nevada, as well as members of the media and citizens of Vernon County.
