THE VERNON COUNTY COMMISSION MET PURSUANT TO ADJOURNMENT, ON TUESDAY, JULY 27, 2010, AT 9:00 A.M.

PRESENT: BONNIE M. MCCORD, PRESIDING COMMISSIONER; NEAL F. GERSTER, NORTHERN COMMISSIONER; AND KENNON R. SHAW, SOUTHERN COMMISSIONER.

### **Emergency Management Issues**

Commissioner McCord reported she went with Vernon County Emergency Management Director, Dennis Kimrey, Thursday, July 22nd, to reprogram radios at the Walker Fire Barn; and on Friday, July 23rd, she delivered the LEOP to Kevin Williams, Chairman of Board of Alderman, Village of Milo. After review Mr. Williams signed off on accepting the County LEOP plan for use by Milo.
