Petition for Vacation of Public Road - Henry Township, Section 7/8

Commission held Final Reading of Petition for Vacation of a Public Road in Henry Township, Section 7/8. The legal description is:

A C Hogan Road located in Henry Township. Beginning 460 feet West of the NE corner of SESW Quarter of Section 8, Township 37N, Range 33W, thence West to the NW corner of SESE Quarter of Section 7, Township 37N, Range 33W, thence North to the NW corner of NESE Quarter Section 7, Township 37N, Range 33W, thence West on the center line of said Section 7, Township 37N, Range 33W to the Missouri Kansas State Line.

A C Hogan Road a 40' wide road ordered open on line 04/22/1884.

After discussion and there being no remonstrance filed, Commissioner Shaw made a motion to vacate the public road in Henry Township, Section 7/8. Commissioner McCord seconded the motion. The motion passed by vote: Commissioner Shaw (Yes); Commissioner McCord (Yes); Commissioner Gerster (Absent).
