#### ROCK HAULING FOR VERNON COUNTY

**JOB INFORMATION** This job entails the hauling, spreading and/or dumping of gravel and rock for Vernon County.

#### **JOB & BID REQUIREMENTS**

1. Operator to be a duly licensed driver in State of Missouri.
2. Vehicle to be of modern vintage, twin screw drive, in good condition.
3. Vehicle to be owned/leased by bidder at bid deadline.
4. Vehicle to be available for inspection prior to bid confirmation.
5. Vehicle to have a 15 ton minimum capacity.
6. Operator to have a minimum of 3 years experience and agree to provide references on request.
7. Bid to be submitted on a per ton basis.
8. Bid to be submitted for a period of one (1) year beginning **January 1, 2018, and ending December 31, 2018.**
9. Bid to be submitted for rock delivery at any location in Vernon County.
10. Bid to be submitted for rock delivery on a prompt priority basis, with availability of additional trucks as required.
11. Proof of \$1,000,000.00 minimum general liability insurance is required at time of bid confirmation for contract period.
12. Comply with all laws and regulations related to and including, but not limited to, wage and hour, prevailing wage, and health and safety.
