KAYSINGER BASIN REGIONAL PLANNING COMMISSION

Commissioner Shaw was nominated by Commissioner McCord to serve on the Kaysinger Basin Regional Planning Commission. Commissioner Gerster seconded the motion. The motion passed by vote: Commissioner McCord (Yes); Commissioner Gerster (Yes); Commissioner Shaw (Absent).

RICHLAND TOWNSHIP

Commissioner Gerster reported on a call he had received from Vernon County Sheriff, Ron Peckman, about a collapsed culvert needing immediate repair on Lady Road, Richland Township, Section 24/25. Vernon County Road and Bridge Crew was notified and had replaced the culvert May 21st.

BATES/VERNON COUNTY COLLAPSED BRIDGE

Commission met with Bates County Commission; Bates County Road & Bridge Foreman, Bill Stevens; Vernon County Bridge Foreman, Lynn Seaver; and Vernon County Assistant Foreman, Mike Reasoner for discussion of removal of bridge over the Osage River that has collapsed at Bacon Township 38N, Range 29W, Section 21. Commissions will request estimates for removal and so notified Tom Priesendorf with the Conservation Department.
