THE VERNON COUNTY COMMISSION MET, PURSUANT TO ADJOURNMENT, ON WEDNESDAY, MARCH 6, 2013 AT 9:00 A.M.

### **FARMERS MARKET**

Kelly Ast with Healthy Nevada called on the Commission to discuss the Farmers Market for 2013. Request was made to have doors open to ground floor for public restrooms. Commission will discuss with the Sheriff regarding security issues.

### **VIRGIL TOWNSHIP**

Shelly Ward called on Commission with road issues in Virgil Township, between Sections 19 and 30. Wesley Greenstreet, Virgil Township Board Member, was contacted and informed the Commission and Ms. Ward the maintainer should be working in that area in the near future.
