THE VERNON COUNTY COMMISSION MET, PURSUANT TO ADJOURNMENT, ON TUESDAY, MARCH 12, 2013 AT 9:00 A.M.

PRESENT: BONNIE M. MCCORD, PRESIDING COMMISSIONER; NEAL F. GERSTER, NORTHERN COMMISSIONER; AND EVERETT L. WOLFE, SOUTHERN COMMISSIONER.

CENTER TOWNSHIP

Commissioner McCord reported on phone call she received March 11, 2013 from Roger Mann, Intermediate Construction Inspector, MODOT, recommending closure of Bridge #632000.5, Center Township, Section 31/Deerfield Township, Section 1, Talley Bend Road, or be reduced to a three (3) ton weight limit. Commission notified Vernon County Bridge Foreman, Lynn Seaver, for immediate closure. Notice was forwarded, via e-mail, to the Vernon County Sheriff; Western Missouri 911 Dispatch Center; Vernon County Ambulance District; Vernon County Emergency Management; KNEM/KNMO Radio Station; Nevada Daily Mail Editor; with copies to Roger Mann, MoDOT, and Darin Hamelink, P.E., Area Engineer, MoDOT.

Commission spoke with Vernon County Bridge Foreman by phone and the 10:30 A.M. meeting was cancelled.
