THE VERNON COUNTY COMMISSION MET,PURSUANT TO ADJOURNMENT, ON TUESDAY, MARCH 19, 2013 AT 9:10 A.M.

### **TRAINING SESSION**

### **EOC BUILDING**

Bill Erwin, Erwin Construction Company, Inc., called on Commission to discuss recommendations for the EOC Building roof repair, including removal of the turbines and replaced with power vents; replace the down spouts, estimated to be \$23,000.00. It would be \$5,000.00 less if the two layers of shingles are removed in advance.
