#### KAYSINGER BASIN REGIONAL PLANNING COMMISSION

Austin Mount, Director; and Sydney Wipff, Kaysinger Basin Regional Planning Commission, called on Commission with regard to Comprehensive Plan for Katy Allen Lake, and Land Use Plan DNR Grant.

Commissioner Gerster made motion to enter into Contract for Services for Katy Allen Lake Plan plus grant applications. Commissioner Wolfe seconded the motion. The motion passed by vote: Commissioner Gerster (Yes); Commissioner Wolfe (Yes); Commissioner McCord (Yes).

Also discussed the Land Use Plan they are preparing for the Department of Defense regarding the Camp Clark area; overview of Economic Development Director for the Butler/Bates County area; the siren project for Vernon County which is part of the County Disaster Plan; and the Main Street in Harwood that is in need of resurfacing.
