THE VERNON COUNTY COMMISSION MET, PURSUANT TO ADJOURNMENT, ON WEDNESDAY, NOVEMBER 27, 2013 AT 9:00 A.M.

PRESENT: BONNIE M. MCCORD, PRESIDING COMMISSIONER; NEAL F. GERSTER, NORTHERN COMMISSIONER; AND EVERETT L. WOLFE, SOUTHERN COMMISSIONER.

PROSECUTING ATTORNEY

Vernon County Prosecuting Attorney, Lynn M. Ewing, III, called on Commission for discussion of request for \$4,000.00 upgrade for the Prosecutor's office server be paid from the Computer Line, and Commission's approval for the Karpel Solutions Contract for hosting Prosecutor's software. Commissioner McCord made motion to approve the Contract. Commissioner Gerster seconded the motion. The motion passed by vote: Commissioner McCord (Yes); Commissioner Gerster (Yes); Commissioner Wolfe (Absent).

Commission also agreed the upgrade should come from the Computer Line item.

WASHINGTON TOWNSHIP

James Hart called on the Commission with complaints of branches overhanging a road in Washington Township, (Clock Shop Road) 1400 Road. He was given contact information for the Washington Township Board and also advised to seek private legal counsel.

SHERIFF

Vernon County Sheriff, Jason Mosher, called on the Commission to discuss need for replacement vehicle after accident. He has located a 2014 Ford Interceptor SUV at Republic Ford/Lincoln he believes to be part of State Bid. He will forward State Contract information for documentation. Commission approved lease/purchase and agreed to amend the budget to show the revenue and expenses from the insurance claim of \$8,966.88. Balance will be reflected in the 2014 Budget.

Commissioner Gerster made motion to amend the 2013 Budget. Commissioner Wolfe seconded the motion. The motion passed by vote: Commissioner Gerster (Yes); Commissioner Wolfe (Yes); Commissioner McCord (Yes).

Vernon County Bridge Foreman, Lynn Seaver, joined the Session and informed the Sheriff of signs, stop signs, railroad crossing signs, and State and County road identification signs had been located in a stream. Commissioner Gerster contacted Darin Hamelink, P.E., Area Engineer, MoDOT, for a price for signs and replacement costs. Sheriff Department will investigate.
