**STEEL BID**

Commission held Bid Opening for Steel for construction by the Vernon County Bridge Department. Those in attendance were: Randy Dillion, Viebrock Sales & Service, LLC; Russell Placzek, Oden Enterprise, Inc.; and Nicole Garner, Reporter, Nevada Daily Mail. Two bids were received as follows:

Viebrock Sales & Service, LLC	\$32,552.00
Oden Enterprise, Inc.	\$30,683.11

Commissioner Wolfe made motion to accept the bid of Oden Enterprise, Inc. in the amount of \$30,683.11. Commissioner Gerster seconded the motion. The motion passed by vote: Commissioner Wolfe (Yes); Commissioner Gerster; Commissioner McCord (Absent).

Discussion was had with regard to delivery of the steel since the bid specified 30 days after bid conformation, and both bids had stated the beams were scheduled to roll February 8, 2014, and delivery would be late March.
