THE VERNON COUNTY COMMISSION MET, PURSUANT TO ADJOURNMENT, WEDNESDAY, JUNE 18, 2014 AT 9:00 A.M.

### **MoDOT**

Dan Salisbury, Assistant District Engineer, MoDOT, called on the Commission regarding acceptance of deed to road connecting Horton to TT Interchange.
