Commission held Bid Opening for Trash Hauling at 2:00 P.M. Proof of Publication was presented. Those in attendance were Commissioners; Ross Rhuems, Sales Representative with WCA; and Michelle Workman, Reporter, Nevada Daily Mail. One bid was received from WCA for \$334.00 per month or \$4,008.00 which includes the twelve (12), four (4) yard dumpsters to be used for collection of cardboard by the Vernon County Recycling Center. The bid also quoted \$35.00 for three (3) yard dumpsters for special occasions.
