THE VERNON COUNTY COMMISSION MET, PURSUANT TO ADJOURNMENT, WEDNESDAY, JANUARY 28, 2015 AT 9:00 A.M.

2015 BUDGET

Commission held Final Hearing on 2015 Budget at 10:00 A.M. RECYCLING CENTER

Commissioner Hardin contacted Jason Stark from Services Recycling to inquire about the payment due for the 4th Quarter 2014. Mr. Stark said he would check on payment and contact Commission.

Commissioner Gerster contacted WCA of Joplin regarding the twelve (12) four (4) yard dumpsters that was to be delivered two weeks ago. WCA quickly called back and informed Commission they would be delivering the dumpsters next week.

SENATOR ROY BLUNT

Dan Wadlington, Representative from Senator Roy Blunt's office, stopped by Commission office and discussed potential grants for Sheriff's cameras which will be available in the fall. He also discussed future BRO projects; BRO funds, as well as numerous other things.

RECYCLING CENTER

Justin Messner, Alternative Opportunities, called on Commission to discuss two potential candidates for the Recycling Center through the Alternative Opportunities program. Commission asked if Alternative Opportunities has programs that could send employees to us to be utilized at the Recycling Center.

BRIDGE DEPARTMENT

Vernon County Bridge Foreman, Lynn Seaver, reported to the Commission that the culvert prices this year would be offered at the same price as last year.

RECYCLING CENTER

Commission received e-mail from Services Recycling with copy of check in the amount of \$4,379.62, representing payment of recyclables for the months of October, November and December, 2014. Commission checked with Vernon County Collector/Treasurer, Phil Couch, and found the check had been received and deposited on January 21st.
