HARRISON TOWNSHIP

Donnie Gast, Harrison Township, called on the Commission with concerns of a bridge on 725 Road, between Harrison Township, Sections 25/26. Commission contacted Vernon County Bridge Foreman, Lynn Seaver, and asked him to check this bridge.
