THE VERNON COUNTY COMMISSION MET, PURSUANT TO ADJOURNMENT, TUESDAY, SEPTEMBER 15, 2015 AT 9:00 A.M.

She did not take them with her; as she states the issue in question is a well-known man and she does not believe anyone will sign a petition against him. She knows the township has maintained that road/drive in the past.
