THE VERNON COUNTY COMMISSION MET, PURSUANT TO ADJOURNMENT, WEDNESDAY, DECEMBER 2, 2015 AT 9:00 A.M.

PRESENT: JOE HARDIN, PRESIDING COMMISSIONER; NEAL F. GERSTER, NORTHERN COMMISSIONER ; AND EVERETT L. WOLFE, SOUTHERN COMMISSIONER.

BIDS

Motion was made by Commissioner Gerster to extend the Trash Hauling bid by WCA for the period of 1 year, at the same price of \$334 per month and \$35 per dumpster on special occasions. Motion was seconded by Wolfe. Roll call vote was taken. Commissioner Gerster (yes), Commissioner Wolfe (yes), Commissioner Hardin (yes). Motion carried.

Pest Control bids were opened at 10:00 AM. Doug Cass was present for bid opening. Motion was made by Commissioner Wolfe to accept bid from Doug Cass Pest Control at the price of \$105 per month for 2016 calendar year. Motion was seconded by Commissioner Gerster. Roll call vote was taken. Commissioner Wolfe (yes), Commissioner Hardin (yes), Commissioner Wolfe (yes).

Concrete bids were opened at 11:00 AM. Present were: Lynn Seaver, DeWayne O'Brien, Jay O'Brien, Zack McInroy, Brent Mendenhall. Lengthy discussion was held after opening the bids. Commission decided that more questions and calculations needed to be done and will award that contract the following week.

Rock Hauling bids were opened at 2:15 PM. Motion was made by Commissioner Wolfe to accept the bid from Dirks and Sons Trucking for \$6.35 a ton for the 2016 rock hauling. Seconded by Commissioner Gerster. Roll call vote was taken. Commissioner Gerster (yes), Commissioner Wolfe (yes) and Commissioner Hardin (yes). Motion carried.

Rock bid was opened at 2:45 PM. Motion was made by Commissioner Gerster to accept the bid from Ash Grove Aggregates.

Motion was made with Ash Grove understanding, as Steve Mellenbruch was in attendance; that if geographical reasons warrant making purchases from elsewhere because we are closer to other places (which is not a frequent occurrence) that Ash Grove understands and will honor that decision.
