THE VERNON COUNTY COMMISSION MET, PURSUANT TO ADJOURNMENT, WEDNESDAY, MARCH 23, 2016 AT 9:00 A.M.

### **KAYSINGER BASIN REGIONAL PLANNING COMMISSION**

Elizabeth Van Winkle and Cassie Sanders called on the Commission to update us on the Katy Allen Lake Project and the grant that helped with the funding. Kaysinger Basin is going to apply for an RTB grant that is due April 22<sup>nd</sup>, 2016. Commission still agrees to do in kind labor and help with the bridges and the dam. Commission and Kaysinger reviewed and discussed what was going to be discussed in Phase I of this project, so that Kaysinger could put it on the application. Provided Elizabeth with a Letter of Commitment for the SET IV grant.

Aimee Meyer, Vernon County Chamber of Commerce Board Member, joined the meeting with Kaysinger to discuss the potential of hiring an economic developer through Kaysinger Basin. Kaysinger Basin would employ the individual as well as manage them. They are going to apply for a USDA grant on behalf of Vernon County that would pay for 50 % of the Economic Developers salary for the first 3 years. The other 50% would be paid by the county and any municipalities that are interested. Commission is to attempt to schedule a meeting with all the municipalities in the near future to discuss this opportunity.

Kelly Ast called on the Commission to give an update on the Youth Pavilion Project. The temporary gravel pad and temporary tent should be in place by the end of April, with the pavilion construction to be completed by May 2017.
