NEVADA LAND CONVEYANCE PROJECT

Commission met with Representative Patricia Pike, Elizabeth Van Winkle and Ashley Schwartz of Kaysinger Basin. Had a conference call with state employees as well as members from the local YMCA and Nevada Regional Medical Center to discuss the possible land conveyance project. There are CDBG grants available of 50% of the demolition costs up to 2 million dollars. State funding will hopefully be available to cover the rest of the cost. Commission scheduled a site visit for 6-1-16 and will discuss their interest in the next week to decide if we want to proceed with applying for CDBG grant and begin the project.
