### **VIRGIL TOWNSHIP**

Linda and Bill Brown, residents of the township called on the Commission to voice concerns of a road dispute in Virgil Township between Section 10 and 11. Neighbors are refusing to quit using the Brown's private drive and have even gotten physical with Mr Brown. Vernon County Sheriff's Office has not been able to assist in this matter. Commission told Mr and Mrs Brown that our opinion is that the road in question is not a public road; but that we have no authority to control it. Recommended Mr and Mrs Brown visit with the township and get their opinion on the road as well as promised them a letter from the Commission stating our opinion; which we will mail next week.
