Motion was seconded by Commissioner Hardin. Motion passed Commissioner Hardin (yes), Commissioner Gerster (yes), Commissioner Wolfe abstained.

11:30 AM Commission opened Mowing and Trimming Bids. 2 bids were received. After review, of the bids a motion was made by Commissioner Wolfe to accept bid from Mutch Needed Lawn Care for \$75.00 per mow. Motion was seconded by Commissioner Gerster and passed by unanimous vote.
