THE VERNON COUNTY COMMISSION MET, PURSUANT TO ADJOURNMENT, TUESDAY, MAY 30, 2017 AT 9:00 A.M.

### **HERITAGE GRANT**

5/25/17 Cassie Sanders from Kaysinger Basin met with Rico (Phishny) at the courthouse to go over the project progress.

5/30/17 Cassie Sanders and Architect John Speweik met to look over the work being done at the courthouse.

Commission received final invoice from Phishny for the project in the amount of \$48,400.

5/25/17 Commission filled out Missouri Heritage Properties Program Grants Requesting Reimbursement forms totaling \$59,750. Received copy of invoice and check the county sent to Phishny in the amount of \$57,250.
