THE VERNON COUNTY COMMISSION MET, PURSUANT TO ADJOURNMENT, TUESDAY, JUNE 6, 2017 AT 9:00 A.M.

PRESENT: JOE HARDIN, PRESIDING COMMISSIONER; EVERETT L WOLFE, SOUTHERN COMMISSIONER; AND CINDY THOMPSON, NORTHERN COMMISSIONER.

SECRETARY OF STATE

Commissioner Thompson attended a presentation at the Nevada Community Center given by Jay Ashcroft in regards to new voter ID legislation.

DOVER TOWNSHIP

6/1/17 Attorney Dustin Dunfield visited the office with some clients. They used the Plat Book to look up some roads/boundaries.

6/1/17 Trustee Jim Clark phoned the office. They did not get any sealed bids on the piece of equipment they advertised. He wondered what steps he has to take next.

BLUE MOUND TOWNSHIP

6/5/17 Road and Bridge Foreman Lynn Seaver phoned the office. He asked if the office could contact the trustee and find out if they maintain a road or not. (2100 Road, North of Dalton Road, leads into 4 Rivers Conservation parking lot.) Office phoned Micah Gayman, Trustee. He states the township maintains Dalton Road, but not sure about 2100. He states the boundaries have never really been clear and that the township and the conservation have always just gotten along in regards to this. He will drive out and assess, then he will call Lynn Seaver so they can discuss. He states he does wish someone would come out and officially establish the boundary.

WALKER TOWNSHIP

Resident Roy Foreman called on the Commission with concerns about C Highway north of Walker. Mr Foreman states that he has been told that the state is going to continue to not maintain it and eventually turn it back into a gravel road. Commission reminded Mr Foreman that we do not have any control or jurisdiction over any state highways and that he should call Representative Pike or Senator Ed Emery. We also told Mr Foreman that Commission would call MoDOT and pass on his concerns.
