THE VERNON COUNTY COMMISSION MET, PURSUANT TO ADJOURNMENT, TUESDAY, MAY 14, 2019 AT 9:00 A.M.

PRESENT: JOE HARDIN, PRESIDING COMMISSIONER ; EVERETT L WOLFE, SOUTHERN COMMISSIONER; CINDY THOMPSON, NORTHERN COMMISSIONER.

KAYSINGER BASIN REGIONAL PLANNING COMMISSION

Sheridan Garman- Neeman called on the Commission to discuss the Census Tract. Kaysinger is authorized to make adjustments and has suggested Census Tract adjustments around Nevada's current industrial park. Sheridan wanted to make sure that this change would not affect the county negatively in any way. Commission saw no negative impact and forwarded that message to Sheridan.

Sheridan also discussed the Rural Community Development Initiative Grant. This is a 2 year grant partnering with the City of Nevada and Kaysinger Basin for a full time Economic Developer for two years. After much discussion about the grant, Thompson made a motion to approve and sign a 'resolution of the County Commission of Vernon County to show support for partnership between Vernon County, the City of Nevada, Kaysinger Basin Regional Planning Commission and the United States Department of Agriculture's Rural Community Development Initiative to create and fund a countywide and regionally affiliated economic development position'. Vernon County's contribution is not to exceed \$18,026.13 per year. Motion seconded by Wolfe and passed by unanimous vote.
