### **VIRGIL TOWNSHIP**

Nathan Thomas, Board Member, visited the office and provided written recommendation for new Clerk to be Becky Werkmeister; signed by current board members. He also provided written resignation of Denise Sloniker , Clerk, signed by the current board and written resignation of Trustee James Boyle signed by the current board.

### **BRO- B108 (44)**

They cannot allow the county to proceed with construction utilizing BRO funds due to their current negative balance . If the county is able to do construction themselves, they could turn this in for softmatch credit. Also received the Critical Incident Finding that documents the closure of the bridge, from MODOT.

Lisa Bowling, Clerk, phoned the office about a culvert needing work off of 43 Highway and Younger Road. It is on the right of way, so they are unsure whether it is a MODOT or county issue. Commissioner Wolfe returned her call.
