**KAYSINGER BASIN REGIONAL PLANNING COMMISSION**

Sheridan Garman- Neeman called on the Commission to discuss numerous topics. First, she is requesting that Vernon County join a grant application for Brownsfield Grants; which would allow Kaysinger to issue sub-grants for Phase 1 and Phase 2 studies to business and landowners. The grant application is due December 3<sup>rd</sup> and Vernon County will send a letter of support for the application. Second, she is requesting that the County Commission find a new expanded Kaysinger Board Member; as the current one has chosen not to extend their term. Lastly, Vernon County has been awarded a USDA 2 year Economic Development Grant which will begin January 1<sup>st</sup>, 2020. Kaysinger will begin interviews with Vernon County participation in the very near future. Sheridan also requested that the Commission try to find office space for this individual within the courthouse. Provided Sheridan with an application that has been turned in already for Economic Developer position.
