## Supreme Court Decision - Deputy Sheriff Salary Supplementation Fund

Commission received a Supreme Court decision regarding the Deputy Sheriff Salary Supplementation Fund (Steve Ehlmann, et al vs.. Honorable Jeremiah (Jay) Nixon, et al.) from Missouri Association of Counties. The decision upholds the Cole County Circuit Courts ruling that the funds are state funds and not county funds; thus, the law does not violate the state's constitution. Counties should continue to collect the \$10.00 fee and remit the funds to the State. Vernon County Collector/Treasurer, Phil Couch, was so informed.
