### **Osage Township Issues**

Rachael Harmon called on Commission with regard to a ditching problem near her home on Gray Road, Osage Township, Section 31. Commission inspected. and advised Mrs. Harmon it was a township issue.

### **Coal Township Issues**

Coal Township Trustee, Charles Comstock, called on Commission with regard to company wishing to run pipeline through a culvert. Commission advised Mr. Comstock permission would not be given to anyone to run pipeline through County culverts. They also advised him permission would need to be obtained from County to run pipeline on County right-of-way
