THE VERNON COUNTY COMMISSION MET PURSUANT TO ADJOURNMENT, ON TUESDAY, APRIL 26, 2011, AT 9:00 A.M.

PRESENT: BONNIE M. MCCORD, PRESIDING COMMISSIONER; NEAL F. GERSTER, NORTHERN COMMISSIONER; AND KENNON R. SHAW, SOUTHERN COMMISSIONER.

Bridge Department Issues

Vernon County Bridge Foreman, Ron Sloan, called on Commission to discuss the log jam in Virgil Township, Section 10/11 on Clear Creek.

He discussed ongoing road and bridge work in the County.

County Clerk Issues

Vernon County Clerk, Tammi Beach, called on the Commission and informed the Commission Jasper County had reimbursed Vernon County for change of venue expenses in the amount of \$1,053.78.

She also discussed the U. S. Cable of Costal Texas, LP agreement.

Also discussed the review of insurance on vehicles and trailers.

Reviewed FMLA certification.

Petition for Vacation of Public Road

Commission was presented with a Petition for Vacation of a Public Road in Osage Township, Section 26. Commission held first reading. Commissioner Shaw made a motion to accept the Petition for Vacation of a Public Road in Osage Township, Section 26. Commissioner Gerster seconded the motion. The vote was: Commissioner Shaw (No); Commissioner Gerster (No); Commissioner McCord (No). Petition was rejected by failed vote due to lack of legal description identifying the location of the road.

Doug Wortman called on the Commission regarding a road in Henry Township, Section 16. After researching in Recorder of Deeds office and Assessor's office, as well as official County Plat Book, Commission cannot find the establishment of public road.

Commission authorized payroll for May 6, 2011. Commission approved time sheets for Ron Sloan, and Tim Bourassa.

Inventory

Commission drafted and sent memo to Elected Officials and Heads of Department regarding inventory that may have been purchased with funds other than general revenue.

Colt Energy

Commission reviewed legal opinion response from Vernon County Prosecuting Attorney, Lynn M. Ewing, III, regarding Colt Energy's inquiry of surface right on Old Highway 54, Coal Township. He had suggested Commission contact the State of Missouri regarding same. Mr. Ewing's opinion was forwarded to Brandon Fisher.

Commission contacted Andy Ellsworth, MoDOT, regarding ownership of road as it pertains to extracting oil and minerals from the right-of-way in Vernon County. He was forwarded a copy of the request from Brandon Fisher, representing Colt Energy, as well as the legal opinion letter from Vernon County Prosecuting Attorney, Lynn M. Ewing, III. He will research this. He also informed the Commission MoDOT is in negotiations with a different oil company to extract oil from MoDOT right-of-way in Vernon County.

Mission

Don Daggett telephoned Commission requesting information for the establishment of a Mission in Vernon County. Commission informed Mr. Daggett State and Federal would pertain and also was given Carol Branham, Housing Authority contact information.

Insurance
