THE VERNON COUNTY COMMISSION MET PURSUANT TO ADJOURNMENT, ON TUESDAY, AUGUST 9, 2011, AT 9:00 A.M.

PRESENT: BONNIE M. MCCORD, PRESIDING COMMISSIONER; AND KENNON R. SHAW, SOUTHERN COMMISSIONER.

Clear Creek Township Issues

Gene Lowe, Clear Creek Township Trustee, called on Commission regarding Clear Creek Township Board issues. He was provided two copies of the Sunshine Law Book.

Old Jail Roof

Mike Hendrix telephoned the Commission regarding the roof at the old jail, and made an appointment for 1:30 P.M. in the Commission Chambers on August 16th.

Commission authorized payroll and payroll benefits checks.

Backflow Device

Tom Charles inspected the backflow device and forwarded the information to Missouri Department of Natural Resources. He also furnished the Commission with Backflow Prevention Assembly Test Data and Maintenance report.

One-Call System

William Dexheimer, Missouri One-Call System, called on the Commission requesting land base parcel information. Vernon County Assessor, Cherie Roberts, was in attendance and he was informed that information is being developed and may be available at the beginning of the year. Commission will discuss with Vernon County GIS Director, Tim Bourassa.

County Clerk Issues

Vernon County Clerk, Tammi Beach, called on the Commission and presented a budget amendment to be forwarded to the State Auditor.

She also presented copy of letter to the Nevada R-5 School District with regard to Nevada R-5 School Resource Officer.

He is proceeding with information regarding cost of restoration and has made offer to the County for the gift of the picture, as well as discussed it with Terry Ramsey, at Bushwhacker Museum.

Assessor Office Issues

Commissioner McCord made motion to approve the Governmental Cooperative Contract between the City of Nevada; Vernon County, and Vernon County Assessor for the assessment of real and personal properties within the corporate limits of Nevada in accordance with RSMo., 2000. Commissioner Shaw seconded the motion. The motion passed by vote: Commissioner McCord (Yes); Commissioner Shaw (Yes); Commissioner Gerster (Absent).

Commissioner approved and sent Governmental Cooperative Agreements between the Cities of Nevada; Schell City; Stotesbury; Walker; Harwood; Sheldon and Richards, and Vernon County Commission for services to be rendered by the County to the City for the 2011 real estate and personal property taxes for their approval and return copy to the County.

PPI/ADM Issues

Vernon County Assessor, Cherie Roberts, called on the Commission to discuss the assessment sheets for ADM/PPI for the 2011 tax year. Vernon County Collector/Treasurer, Phil Couch and Vernon County Clerk, Tammi Beach, were asked to join the session. Telephone call was made to County's Attorney, Deborah Polk, Armstrong Teasdale, for clarification.

She also updated the Commission on contract with ADM's Bond Counsel that should be closing August 10th at 1:00 P.M., therefore penalties for 2010 could be forwarded to the County shortly thereafter.

Commission inspected the Vernon County Sewer District sewage lagoon; fairgrounds, recycling center, EOC; and Road and Bridge barn.
