The Vernon County Commission is soliciting sealed bids for **ROCK** for use in construction by the Vernon County Road & Bridge Department.

1. All rock shall conform to Missouri Standard specifications for Highway Construction, 2018 Version, including revisions, Section 501.
2. All prices quoted are to be per ton.
3. Delivery, under the blanket purchase order, shall guarantee delivery at the specified time. Failure to meet delivery standards will be considered a breach of the blanket purchase order and may allow termination of said order by the Vernon County Commission or purchase of rock from another vendor to satisfy the requirements of the Road & Bridge Department.
4. Prices quoted must remain firm for the period beginning **January 1, 2025, to December 31, 2025.**
5. Sealed bids, marked "ROCK", shall be delivered to the Vernon County Commissions Office, First Floor, Vernon County Court House, by **4:00 P.M., Monday, December 9, 2024, to be opened and read aloud at 11:30 P.M., Wednesday, December 11, 2024,** by the Vernon County Commission.
6. Proof of \$1,000,000.00 minimum general liability insurance is required at time of bid confirmation for contract period.
