### INVITATION TO BID CONCRETE

The Vernon County Commission is soliciting sealed bids for **CONCRETE** for use in construction by the Vernon County Road & Bridge Department.

1. All concrete shall conform to Missouri Standard specifications for Highway Construction, 1999 Version, including revisions, Section 501.
2. A blanket purchase order will be awarded. The exact quantities of each item are not known. There will be no penalty in price or delivery for failure to meet any specific quantity.
3. All prices quoted are to be **per cubic yard including delivery** to any location in Vernon County.
4. Delivery, under the blanket purchase order, shall guarantee delivery at the construction site at the specified time. Failure to meet delivery standards will be considered a breach of the blanket purchase order, and may allow termination of said order by the Vernon County Commission or purchase of concrete from another vendor to satisfy the requirements of the Road & Bridge Department.
5. Prices quoted must remain firm for the period beginning January 1, 2018 to December 31, 2018.
6. **Sealed bids, marked "Concrete" shall be delivered to the Vernon County Commissions Office, First Floor, Vernon County Court House, by 10:45 A.M., November 29, 2017, to be opened and read aloud at 11:00 A.M., November 29, 2017 by the Vernon County Commission.**
7. Proof of \$1,000,000.00 minimum general liability insurance is required at time of bid confirmation for contract period.
8. Bidder must comply with all laws and regulations related to and including, but not limited to, wage and hour, prevailing wage, and health and safety.
9. Questions on these bid specifications should be addressed to the Vernon County Commission.
