VERNON COUNTY TRASH HAULING

JOB INFORMATION: Job consists of complete **TRASH HAULING SERVICE** for Vernon County Court House, Jail, Centennial Fairgrounds, and Bridge Barn.

JOB SPECIFICATIONS:

1. Trash to be hauled to an approved sanitary landfill.
2. Proof of \$1,000,000.00 minimum general liability insurance required at time of contract.
3. Twice weekly pick up.
 - A. 2 yard metal dumpster type container with cover at the Court House.
 - B. 3 yard metal dumpster type container with cover at the County Jail.
4. Once a week pick up.
 - A. 4 yard metal dumpster type container with cover at the Home Ec Building, Fairgrounds.
 - B. 2 yard metal dumpster type container with cover at the Road & Bridge Barn, 400 North Colorado
 - C. 2 yard metal dumpster type container with cover at the Fairgrounds Arena **for the six month period, MAY THROUGH OCTOBER**

5. Price for 3 yard dumpsters during **Special Occasions**. \$_____per dumpster.

6. Provide twelve (12) 4 yard dumpsters for collection of cardboard for Vernon County Recycling Center for the purpose of reducing trash going to landfill.

7. Payment will be made on a monthly basis.
